WAYS OF SUPPORTING THE AEC

- A monthly debit order.

WHAT THE BURSARY COVERS

School fees at a negotiated fee discount, transport, school uniform, textbooks, stationery and the necessary IT devices such as a laptop or tablet. The bursary is comprehensive so that the learner can concentrate on studying.

Costs from 2027 onward assume an increase of R5 000 a year and are indicative. A half bursary, R32 500 in 2026, is equally welcome: two donors then carry one learner together.

Tax and B-BBEE benefits
